1 Meetings of Committees

1.1 General Meetings

The ordinary meeting was held in Geneva on 24 April 2018 and an extraordinary meeting in Barcelona on 29 October 2018.

1.2 Executive Committee (EC) Meetings

Two meetings were held during 2018:

- One ordinary meeting in Geneva on 24 April 2018.
- One ordinary meeting in Barcelona on 29 October 2018.

Amongst others, the following topics were discussed in 2018:

Continuation of ARCO ISO 17065 accreditation

There is an impact on Qualanod, as so far the running costs of the accreditation were shared by ARCO Association Management AG, Qualanod and Qualicoat. Once Qualicoat had left the share for Qualanod would become much bigger than now. ARCO was instructed to contact the Swiss Accreditation Authorities and to ascertain the various possibilities (inclusion of Qualisteelcoat, maintaining the current valid accreditation of Qualanod) and submit until the next meeting in 2019 concrete proposals inclusive their financial impact.

Composition of the secretariat as from 2020

Mr. Kauer and Mr. Lanz presented themselves and reminded that at the end of August 2018 the General Licensees and the members of the Committees had been informed about the new composition of the secretariat after the retirement of Mr. Schoppig. A transfer from Mr. Schoppig's activities to the new persons would be assured by a transition period in 2019. Mr. Lanz would become the responsible person for Qualanod within ARCO and would obviously still be supported by Ms. Kägi. Mr. Kauer would be the deputy of Mr. Lanz in case he was unavailable.

1.3 Technical Committee (TC) Meetings

Two meetings were held during 2018:

- One ordinary meeting in Geneva on 24 April 2018.
- One ordinary meeting in Barcelona on 29 October 2018.

Amongst others, the following topics were discussed in 2018:

Procedure for granting and renewing of licences if parts of the inspections are negative or not executed

Mainly in plants that have a licence for more than one type of anodising, there can be potential problems of renewing a licence if insufficient material is available. Following several discussions, TC finally appreciated the proposal that all types should at least



be tested during one of the two annual inspections. If this was not possible, then the scope of the licence would be limited in the following year to those type(s) for which at least one inspection had been satisfactory. However, the rule of passing two satisfactory inspections would be maintained. The secretariat was asked to consider the matter further and to take into account table 1 of the Specifications which stipulated the number of samples to be taken depending of the lot size. Additionally, the secretariat should handle concrete cases and find pragmatic solutions regarding the issue of renewing the licences for anodisers with several licensed types.

Official Qualanod testing form for new products and processes

The QUALANOD "General Regulations" stipulated the procedure for granting licences and testing new products and processes. So far, no official QUALANOD testing form had been introduced, and the various testing laboratories sometimes reported the results in different ways using their own forms. The secretariat disseminated this form to the testing institutes.

Form "Agreement with customers"

A table which could be supplied by the customer in a uniform manner and which would indicate important information such as the intended service of the articles to be anodised will be prepared.

Digitalised inspection report

The secretariat was asked to provide an offer for a digitalised version of the inspection report until the next TC meeting in 2019.

Publication of new documents

Following discussions about several technical issues, several documents (Specifications, General Regulations, Inspection report, Report new product and processes) were modified in 2018, valid from 1 January 2019. The amendments were so far directly included in the documents and they were distributed to all relevant parties.

1.3.1 Label Committee (LC) Meetings

No meetings were held in 2018 and no particularities regarding results of inspection were dealt with.

1.3.2 Working groups

As the convenors of some working groups had resigned as TC members or were not anymore actively following the scope of the respective working groups, the Technical Committee decided to deactivate all current existing working groups and to create new ones as required. The list would be stored by the secretariat for historical reasons.

1.4 Management Committee

No such meeting was held in 2018.



2 Summary of other decisions and activities

2.1 Elections

Mr. Deyhle was re-elected as auditor for 2018.

2.2 Number of licensees

The number of licensees increased during the year.

In 2018 AMELAQ became the General Licensee for Mexico and the first QUALANOD licence was granted in Serbia and Sri Lanka.
