## 1 Meetings of Committees

# 1.1 General Meetings

The ordinary meeting was held in Zurich on 3<sup>rd</sup> May 2022 and an extraordinary meeting in Paris on 18<sup>th</sup> October 2022.

#### **Scale of Contributions**

During the General Assembly it was decided to adjust the annually fees by 10 % as of the 1<sup>st</sup> of January 2023 due to the high inflation rate.

## 1.2 Executive Committee (EC) Meetings

Two ordinary meetings were held during 2022:

- One ordinary meeting in Zurich on 4<sup>th</sup> May 2022
- One ordinary meeting in Paris on 18<sup>th</sup> October 2022

Amongst others, the following topics were discussed in 2022:

#### Accreditation

The EC has decided that before further steps can be taken, a meeting with the accredited general licensees should take place.

## Organic sealing

The question whether organic coating might be more in line with coating instead of anodizing was passed by the TC and EC. The EC decided that organic coating is more like coating and therefore closed the resolution.

#### Digitalized inspection report

Two possible options were discussed, the first being to continue with the existing database or the second being to create a new database with a new provider. It was decided that the second option would be investigated in more detail and offers would be obtained, whereby the provider of the Qualisteelcoat database would also be considered.

#### **Trademark**

QUALANOD decided to strengthen the protection regarding trademarks for the QUALANOD name. Proposals have been invited form trademark agents and the secretariat are to proceed with additional trademark protection

# Examination of compliance with current sanctions regulations

It was decided that a legal opinion would be sought to determine whether QUALANOD complies with the current sanction's regulations of the Swiss government. It was determined that the regulations are currently being followed (status October 2022).

#### Procedure to assess the capability of new processes

The decision regarding the cost and validity of this certificate was passed on by the Technical Committee to the Executive Committee. They have decided to adjust the annual fee for approvals according to the Table of Contributions. For the new procedure, a certificate will be issued which is valid for a period of 5 years.



## 1.3 Technical Committee (TC) Meetings

Two ordinary meetings were held during 2022:

- One ordinary meeting in Zurich on 3<sup>rd</sup> May 2022
- One ordinary meeting in Paris on 17<sup>th</sup> October 2022

Amongst others, the following topics were discussed in 2022:

#### Official documents

Several smaller updates in the official documents (Specifications, General Regulations, Inspection report, sample report) were discussed and updated documents will be valid from March 2023.

#### **New processes**

The TC agreed that the General Secretariat can approve provisional approval in case of a unanimous positive recommendation by the Working Group. In addition, the thermal craze resistance test should be added to the laboratory tests for new processes.

## Procedure to assess the capability of new processes

A draft for the General Regulations describing the procedure to undertake the capability assessment was presented. This was agreed by the TC and forwarded to the EC.

# 1.3.1 Label Committee (LC) Meetings

No meetings were held in 2022, but one appeal regarding the result of inspection were dealt with in an anonymous way in writing. The appeal was rejected as the regulation was clearly stated in the QUALANOD specifications.

## 1.3.2 Working groups

The working group "test methods" has new members, which means that the group now consists of Robin Furneaux (Convenor), Rute Fontinha, Peter Watts, Irene Marcolungo, Metin Yilmaz and Mélanie Grammaticopoulos.

The working group "colour measurement" was renamed working group "appearance" and now consists of Irene Marcolungo (Convenor), Robin Furneaux, Peter Watts, Metin Yilmaz, Mélanie Grammaticopoulos, Roland Prenger and Joan Serret.
